



## **Greater Kansas City Chamber of Commerce** **2025 MISSOURI PUBLIC POLICY AGENDA**

*Approved by KC Chamber Board of Directors – November 18, 2024*

The Greater Kansas City Chamber of Commerce, representing 2,000 employers in the bistate region, calls on policymakers to work across geographic and party lines to plan for inclusive and equitable growth; invest in transformational regional projects such as the 2026 World Cup; advance the shared prosperity, health, and safety of all residents and workforce including expanded support for accessible public education; collaborate with local partners to retain the region’s professional sports franchises; and work to improve opportunities for local control. The Chamber invites policymakers to join it in achieving its ultimate goal to make Greater Kansas City inclusive of all its residents.

### **PROSPEROUS ECONOMIC DEVELOPMENT**

The KC Chamber supports a pro-business environment, the reduction of red tape, and investment in effective and efficient economic development programs and financing tools to help the Kansas City area grow and remain globally competitive. The Chamber takes the following positions:

- Support for the 2025 KC Consensus Agenda on Economic Development; including the continued development of an innovation district and health sciences district in downtown Kansas City, MO.
- Support investment in greater Kansas City’s role as host of the 2026 World Cup.
- Support measures to expand access to capital for small business and businesses in LMI communities, including angel tax credits.
- Support policy to enhance the Kansas City Animal Health Corridor and National Security Crossroads initiative.
- Support investment in bioscience research and infrastructure, including the KC Bio Hub.
- Support tax certainty for employers and employees regarding remote work allowing employers to determine the location where remote work is deemed to be performed, and advocate for balanced taxation and fiscally responsible measures that don’t eliminate critical safety-net investments.
- Support evaluation of available and sustainable resources for economic development.
- Support the preservation of local taxing and spending authority, including the extension of the Kansas City, MO earnings tax renewal authorization period.
- Support the reauthorization of the Missouri Amateur Sporting Tax Credit Program.
- Support Federal and State economic development investment and financing tools, including programs such as LIHTC, MTC, and the Historic Preservation Tax Credit Program.
- Support funding for the Missouri Arts Council, as well as related arts and humanities programs, whose collective investments help support a \$1.7 billion industry in the state of Missouri, and a \$618 million industry in the KC region.
- Oppose expansion of sales tax on professional and labor services.

### **BUSINESS-FRIENDLY CLIMATE**

In an increasingly complex 21<sup>st</sup> century economy, the KC Chamber calls for a climate of legislative and

regulatory predictability and efficiency including measures to ensure all who want to work in our state and region are welcome, allowing businesses to grow. This includes supporting:

- Added protections for employees based on sexual orientation, gender identity or expression and opposing legislation that enables discriminatory policies of any kind.
- Support any legislation that identifies avenues to a safer community, including equitable and data-informed policies that address root causes and reduce crime in metropolitan areas.
- Measures to improve Missouri's legal climate by supporting civil justice reform and opposing legislation that would create or expand liability.
- Policies to secure and enforce the right to vote and make voting safe and accessible for all voters while maintaining election integrity.
- Modernizing the state's initiative petition and referendum process to ensure a fair and transparent process.
- Adequate funding of the judiciary and a non-partisan, non-election process for selecting quality judges.

### ***Military Affairs***

The KC Chamber supports stable funding for the military services at a level that maintains end strength necessary to ensure our forces' readiness and lethality; efforts to increase the quality of life for Service members and their families, including more opportunities for spousal employment and better connection to jobs for those who transition out of the military; and investments in infrastructure and capacity at our region's installations and within the defense industrial base.

## **EDUCATION & WORKFORCE DEVELOPMENT**

### ***Early Childhood Education & Child Care***

Access to quality child care and early education continues to be a dominant barrier to attracting new and returning members to the workforce. The KC Chamber calls on the Missouri legislature to pass the Child Care Tax Credit Act and other measures to expand access to, and affordability of, child care and early childhood education. This includes supporting:

- Measures to improve recruitment and retention of quality educators who prepare the early childhood workforce.
- Increasing the supplemental allocation to support Pre-K and efforts to expand home visiting programs.
- Child care access for late-evening/early-morning shift workers.
- Infant/toddler special education.

### ***K-12 Education***

The KC Chamber believes the success of all students and our community requires a high-quality public education system with sufficient funding, adequately and competitively compensating teachers and education support staff and keeping data-informed high standards for transparency, performance, growth, and outcomes aligned with community and workforce needs. The Chamber supports measures to enhance teacher preparation, recruitment, and retention and advocates for local authority of school boards and non-partisan school board elections. The Chamber takes the following positions:

- Support measures to assist and incentivize competency-based education to align with local workforce needs.
- Support measures to increase dual credit/dual enrollment programs, including the A+ Schools Program.
- Support policies designed to improve climate and culture in the classroom.
- Oppose diverting federal or state funds from public schools including withholding, tuition tax credits, scholarship tax credits, and vouchers.

- Support policies and funding that enhance much needed behavioral and mental health initiatives in schools.
- Advance policies intended to improve literacy outcomes for students.

### ***Higher Education & Post-Secondary Opportunities***

- Support core appropriations requests from the Department of Higher Education and Workforce Development for public higher education institutions.
- Support the state’s higher education institutions and investments in significant regional higher education assets.
- Support efforts by state lawmakers to capture federal research funding for all Missouri public universities.
- Support measures to stimulate career, technical, and trade education in the state, including Access Missouri, Fast Track, MoExcels, and STEAM education and workforce development initiatives.

### ***Workforce Development***

- Support state investment in workforce development including programs that help increase internships, apprenticeships, workplace readiness, adult education, and workforce certification programs.
- Support policy and strategies to improve access to safe, quality, healthy, and attainable housing that is affordable to our workforce.
- Support policies to make the state and greater Kansas City region more attractive and accessible to the immigrant workforce.
- Support workforce training, re-entry programs, and other criminal justice initiatives that encourage returning citizens and other at-risk citizens to become employed and reduce recidivism.
- Support measures to expand bistate training, certification, reciprocity, and credentialing opportunities.

### **HEALTHY COMMUNITIES**

The KC Chamber supports measures to advance quality healthcare and address social determinants of health. This includes supporting telehealth; mental health and wellness initiatives that ensure sufficient funding for providers; and the improvement, collection, and access of public health data. The Chamber takes the following positions:

- Support full implementation including efficient application determination and funding of MO HealthNet, especially to help cover uninsured populations.
- Support investments in a strong state and local public health infrastructure to ensure that communities are protected from and able to respond to public health threats, including the national 988 suicide and mental health crisis hotline.
- Support the appropriation of opioid settlement dollars awarded to the state to support the behavioral health needs, including increased mental health services, substance abuse treatment, and harm reduction programs.
- Generally opposed to healthcare benefit mandates and provider mandates.
- Support funding for Graduate Medical Education (GME) slots in physician-shortage specialties.

### **SUSTAINABLE INFRASTRUCTURE**

#### ***Transportation***

The KC Chamber supports appropriate investment in all modes of transportation infrastructure throughout the region, which includes supporting:

- Effective and innovative ways to help capture and maintain federal investment.
- Funding to promote, study, and advance regional approaches to public transit and transportation planning including access to state networks and facilities.

- Encourage safe, efficient transportation that promotes access to regional, national, and international markets and opportunities vital to regional needs.
- Funding the upgrade of roads, highways, waterways, passenger and freight rail, and air travel in a responsible, efficient, and cost-effective manner will allow the state to meet its transportation-related quality of life priorities, which include safety, economic development, technological advancement, and workforce development.
- Policies that allow local and state government agencies the flexibility to use progressive and collaborative alternative delivery models for projects.
- Support MoDOT’s littering enforcement initiatives to reduce trash along streets and highways.

### ***Digital Equity and Broadband***

Quality and affordable broadband infrastructure is important to support business operations, enable entrepreneurs to start and grow new businesses, and help residents learn and engage in the 21<sup>st</sup> century economy. The KC Chamber supports investments in middle and last mile broadband infrastructure, digital equity, and the deployment of funding in our region through programs such as public-private partnerships including opportunities resulting from the Infrastructure Investment and Jobs Act.

### ***Energy & Environment***

The KC Chamber encourages investments in renewable energy, balanced energy solutions, energy efficiency and reliability and supports policies that support public health and environmental protections that do not unduly burden industry, business, and Missouri residents. The Chamber also supports policies that will not eliminate energy options for local consumers or mandate fuel sources or energy-specific technologies. The Chamber supports the development and voluntary use of affordable and reliable energy resources to deliver energy to Kansas City and other high-demand areas. The Chamber also supports transmission policies that get renewable energy to market and enable partnerships between local utilities and landowners.
