

### **Inspiring Regional Cooperation**



## WELCOMING KC: BUILDING A STRONG WORKFORCE AND THRIVING COMMUNITY

he Greater Kansas City Chamber of Commerce, in partnership with the REACH Healthcare Foundation, launched the Welcoming KC initiative that champions the integration and inclusion of legal immigrants and refugees across our region. Launched as a pathway to create a more inclusive and vibrant Kansas City, Welcoming KC aligns closely with the Chamber's Strong Workforce and Inclusive Prosperity strategic imperatives, which emphasize workforce development as a cornerstone of economic growth.

At its core, Welcoming KC recognizes that immigrants and refugees bring valuable skills, perspectives and entrepreneurial spirit to our community. By supporting these and all newcomers, Kansas City not only upholds its values of inclusion and belonging but also addresses critical workforce needs. Businesses benefit directly from the diverse talents and innovation that new Americans contribute, making this effort essential for sustaining regional economic growth and competitiveness.

Welcoming KC has set an ambitious goal of achieving Certified Welcoming status, a

designation awarded by Welcoming America, by the end of 2025. This milestone will affirm Kansas City's commitment to creating an inclusive community where everyone feels they belong. Considerable progress has been made in the past year, including enhanced partnerships with local businesses, nonprofits and government agencies. Together, these collaborations are helping to build robust programs that support workforce development, cultural understanding and community engagement.

"Welcoming KC links nonprofit organizations, local government and communities together to build a cohesive ecosystem for our newest neighbors," said Councilmember Wes Rogers. "Kansas City will always be a welcoming place for immigrants and refugees as they add to the social fabric of our city and create an enormous positive economic impact. The faster the city embraces and helps immigrants and refugees adapt to life in our city, the better off we all are."

For those directly involved in this work, the impact is personal and profound. As Komal Kaur, founder of Eye of an Immi-



grant, shared:

"Welcoming KC holds a deeply personal significance for me as the daughter of immigrants. I've witnessed how inclusion can transform lives and open doors for individuals and families like mine to thrive and contribute. Welcoming KC is not only creating a sense of belonging but is also driving workforce development and strengthening Kansas City's economy by embracing diverse talents and perspectives. A welcoming environment ensures that everyone can succeed, enriching our community and fostering a vibrant, culturally dynamic region. Kansas City is becoming a place where all stories are valued and I'm proud to see the impact it's making."

Zik Nwanganga, CEO/Founder of ULOM APP, a partner organization that helps refugees, international students and new migrants adapt to their new home faster by connecting them to the right resources and community, concurs with Kaur's sentiments: "ULOM's partnership with Welcoming KC has been vital in supporting refugee and immigrant communities as it plays a crucial role in advocating for those who often go unheard, ensuring they feel seen and supported," Nwanganga said. "For many immigrants and refugees, knowing there's a community ready to help makes all the difference. We're grateful for the incredible work Welcoming KC does and look forward to building on this collaboration."

As we move closer to achieving Welcoming status, businesses and community leaders are invited to join this transformative journey. By working together, we can ensure that Kansas City continues to grow as a beacon of opportunity, inclusivity and belonging, where all residents can reach their full potential and contribute to a thriving regional economy.

### Lenders' Forum: Bridging Gaps in Understanding


Lenders' Forum brings together financial institutions, community lenders and small business owners for candid conversations about access to capital. The Forum served as a bridge, fostering dialogue between lenders and borrowers to demystify lending practices and clarify the requirements for securing funding. Held every two months, these events emphasize relationship-building and showcase local businesses.

### Capital Connections: Empowering Entrepreneurs

The KC Chamber's Capital Connections series provides an informal platform for entrepreneurs to connect directly with lenders and Entrepreneurial Support Organizations (ESOs). These networking events highlight opportunities for businesses to discuss their ideas, hear feedback and discover resources. 
paced, on-the-go users. Thank you to Chamber member Prelude agency for their support on this project.

### Emerging Small Business of the Year: Cyphr

Cyphr processes and enriches financial data with 95% accuracy, automating transaction reconciliation and increasing capacity for financial teams that allow them to make more informed, less-biased decisions. Established in 2022, this Emerging Business leader is making a substantial impact with the goal of serving 100 lenders that deploy \$1 billion annually to small businesses across the country. Cyphr had already grown its employee base from two to 10, raised \$2.2 million in capital and earned \$210,000 in revenue in the first 45 days after launching.



### Legacy of Kansas City: Pro Athlete

For nearly 40 years, Pro Athlete has fostered a dynamic workplace by blending a passion for sports with a vibrant culture that encourages teamwork, innovation and creativity. Renowned for its product expertise and exceptional customer service since opening in 1987, this local small business also ensures a fun work environment where employees thrive. While the business model may have shifted from brick-and-mortar to online sales, Pro Athlete's commitment to Kansas City remains the same with a history of dedicated support to charity initiatives.



### Weida Award for International Small Business of the Year: Shark OFF

Who knew that there is technology that exists to repel sharks? Shea and Geoff Geist, that's who!

The owners of Shark OFF created a business to help people "Lose the Fear and Love the Ocean" with proven shark-repellent jewelry. Packaging this proven, effective electrochemical technology as attractive, affordable jewelry has inspired sales all over the world. A small but mighty company, Shark OFF runs off the servant leadership mindset of its two owners and a single contract employee.

### Small Business Equity Award: Taliaferro & Browne

Deep connection to the revitalization of some of Kansas City's historic neighborhoods is part of Taliaferro & Browne story as one of Kansas City's largest Black-owned multi-disciplinary firms specializing in civil engineering, structural engineering, landscape architecture, land survey and construction inspection. ### Luminary Arts & Creative Small Business: Wandering Bud

A new Small Business Celebration award in 2024, the Luminary Arts & Creative Small Business Award was created to recognize artist-founded and/or artist-run businesses that produce original work and products and maintain individual ownership of their intellectual property. Founded in 2016, Wandering Bud creates ceramic smokeware that is designed to accentuate home décor. Wandering Bud's pieces are all homemade by local artists and the company has grown a faithful community of collectors.

The ATHENA Awards are named after the Greek goddess Athena, symbol of intelligence, wisdom, arts, and sciences, and recognizes not only exemplary leadership and service, but also honoring an individual who has actively assisted in opening doors for others.

As President and CEO of Health Forward Foundation, 2024 ATHENA Award winner Qiana Thomason guides the \$1B foundation in stewarding diverse capital investments, leadership in public policy, and institutional social capital that fosters health and economic inclusion throughout the Kansas City region. ### Champion of Diversity: H&R Block

The Belonging@Block initiative at H&R Block goes beyond social connection, embedding inclusivity into the company's core operations. Through a combination of training, leadership development, and advocacy, the program seeks to build awareness around unconscious bias and empower employees to drive change from within. Block also supports initiatives like mentoring programs and inclusive hiring practices, ensuring representation at all levels.

Inclusion at H&R Block results in a vibrant

workplace culture. Programming ensures that employees feel a deep sense of belonging, regardless of their backgrounds, by fostering a community that celebrates differences and promotes collaboration. Central to Belonging@Block are the Employee Resource Groups (ERGs), which are spaces for employees from different backgrounds to connect, support one another, and advocate for change. No fewer than seven ERGs support various identities, including race, gender, LGBTQIA+ and more, providing a platform for voices that have historically been marginalized.

### Ace Award: Anna Bazan-Munguia, Big Brothers Big Sisters of Kansas City

As the Director of Community Outreach, Anna Bazan-Munguia leads efforts to ensure that the programs



of Big Brothers Big Sisters of Kansas City are inclusive and reflective of the communities it serves. Bazan-Munguia has a strong commitment to engaging underrepresented groups and fostering equity through mentorship and outreach initiatives. "When you are passionate about making a difference and having the opportunity to work with so many amazing people, internally and externally, it is so rewarding that it feels as if you aren't working at all," Bazan-Munguia reflected.

### Ace Award: Kelly Hass, Kansas City National Security Campus, managed by Honeywell FM&T

Frequently experiencing situations where she was the only woman in the room, Kelly Hass learned early on in



her career that representation and communities of belonging matter. In her role as a Senior Quality Director at KCNSC, she has helped drive initiatives aimed at creating a more inclusive and equitable culture. Hass' work emphasizes creating spaces where all employees feel valued, heard and empowered to contribute fully. One of her primary focuses has been on implementing strategic policies that not only improve representation but also address systemic barriers within recruitment, retention, and career advancement.

### Ace Award: Jenn Miller, Henderson Building Solutions

As the Director of Business Development at Henderson Building Solutions, Jenn Miller has been



instrumental in cultivating a culture that promotes representation and belonging across the firm. Prioritizing inclusion, Henderson is not only enhancing its workplace culture but also ensuring more holistic, creative problem-solving within its project teams. And Miller's impact extends beyond the firm, as she advocates for broader industry-wide changes to make engineering more accessible and equitable for all.





## KC CHAMBER FOUNDATION FY24 PROGRAM HIGHLIGHTS

### genKC

- genKC put on 4 networking events in 2024 that brought together over 500 early career professionals from the Kansas City area.
- genKC had over 200 attendees for a 2024 Financial Literacy panel that discussed microeconomics.
- At a networking event hosted by genKC, more than 390 pounds worth of goods were collected that were donated to Big Brothers Big Sisters.
- genKC held a book drive for Lead to Read in October and collected over 450 books.

- Worked with KCMO City Council to pass. ordinances for Office of Language Access
- Worked with New Americans' Commission to develop plan for KCMO Office of Immigrant and Refugee Affairs

### Workforce

 2024 Public Policy activities addressed barriers to workforce development in areas including, but not limited to, transportation, childcare, K-12 education, and housing through informational convenings, legislative advocacy, and stakeholder engagement.

### **Centurions Actives/Alumni**

- Centurions awarded over \$32,000 in Scholarships, including over \$15,000 for the Alumni Legacy Scholarship which provides full tuition, trip fees, and KC Chamber membership for a professional of color.
